The program essentially has two broad components –technical and behavioral.
- ➤ The technical component shall enable the participants to understand Company business, strategies, industry dynamics and its growth plans and prepare them for an active role in Company. The behavioral component shall empower the participants to understand board procedures and help them to be effective in board activities.
- > The Program also aims to offer a conceptual framework based upon current expectations which require the Independent Directors to adhere to a code and standard of ethics and integrity for fulfillment of their responsibilities in a professional and faithful manner to promote confidence of the investment community particularly minority shareholders, regulatory authorities and the stakeholders at large.
- ➤ The Company may circulate news and articles related to the Industry on a regular basis and may provide specific regulatory updates from time to time.
- Familiarization process for the Independent Directors generally forms part of the Board Meetings and Independent Director's Meeting.

 - To update Independent Directors of the Company regarding Business Operations, Organizational structure, Subsidiary & Group companies, and their businesses.
 - To update the Rights and Responsibilities of Independent Directors in line with the statutory amendments;
 - To update on recent changes in the regulatory framework;
- Independent Directors have the freedom to interact with the Company's Senior Management Personnel to discuss matters pertaining to the Company's affairs.
